### A Message from the Board

*As we reflect on another remarkable year for the Charitable Foundation of Aiken, we want to extend our heartfelt thanks to everyone who has supported our mission. Your generosity and commitment have made a tremendous impact on our community. We proudly presented a check for \$25,000 to The Aiken Center for the Arts and a check for \$25,000 to Family Promise of Aiken County. Together, we've helped countless families and individuals find hope and opportunity.*

### 2025 Highlights

The Foundation provided funding to **The Aiken Center for the Arts** to support the Arts and Music Camp for special needs children, Joy in the Journey for Alzheimer's and dementia patients, the Aiken Youth Orchestra and ensemble, and art camps for children ages 5-10.

The Foundation provided funding to **Family Promise of Aiken** allowing them to offer one-on-one case management support for families with children that are experiencing homelessness or at risk of homelessness.

The first annual **Polo n Blues** Fundraiser to benefit The Foundation raised \$13,000.

The Foundation announced that the 2025-2026 beneficiaries are **The Clubhouse Community of Hope** and **Public Education Partners of Aiken County**.

**The Clubhouse Community of Hope** is a community-based service dedicated to supporting and empowering people living with mental illness, known as Clubhouse members. Clubhouse members can recover by gaining access to opportunities for employment, socialization, education, skill development, housing and improved wellness.

**Public Education Partners (PEP)**. Public Education Partners has united educators, business leaders, service organizations, and individuals who believe strong public schools are the foundation on which we, the community, will build the future of Aiken County.

MaryAnn moved to Aiken in 2015 after retirement from software consulting following a 25+ year career working for large IT companies. The Aiken area had so much to offer for retirees to keep busy doing sports, volunteering, and events that she quickly identified her interest and jumped right into volunteering for non-profits. A few months living in Aiken saw her join a non-profit, Women of Woodside and serve on their board for several years. MaryAnn likes to keep busy, so she also joined the SPCA Albrecht Center

volunteer group working with the animals and helping at events. A need was seen to build a dog park for exclusive use for shelter animals, and she organized several golf tournaments to raise money to build the park. She was a member of the board for several years and worked as Event Chair organizing large events to raise money to support the shelter.

The Executive Board of the Charitable Foundation of Aiken asked MaryAnn to join the Advisory Committee in 2024 to lend her experience with fundraising events and kickoff their first large fundraiser. The named event – Polo n Blues centered on a polo match, outdoor barbecue, raffle, and silent auction. It was successful and she is now working with her co-chair to hold the second annual Polo n Blues on Saturday, May 16 at La Bourgogne polo field in Wagner.
